MARION CONSERVATION COMMISSION
MINUTES OF THE REGULAR MEETING HELD ON JUNE 9, 2010

Meeting convened at 7:00 PM Wednesday, June 9, 2010 in the conference room of the Marion Town House, 2 Spring Street, Marion, Massachusetts. There were no scheduled site inspections for Saturday, June 5, 2010. L. Dorman took the minutes of the meeting in the absence of the secretary.

7:00 PM **INDIAN COVE TRUST** - RFD (41D-1420) to add approximately 50 cubic yards of crushed stone to eroded areas of the revetment at the boat ramp at the end of Indian Cove Road (continued from May 26, 2010). William St. Cyr represented the Trust. He said the area to be covered is from the boat ramp along the wall to the Mattapoissett line, and there will be a separate filing with the Mattapoissett Conservation Commission for the portion of the work in Mattapoissett. Small (2") crushed stone will be used, and Michael Murphy will do the work by small truck with a backhoe, one bucket at a time. No liner is anticipated, just fill. The salt marsh along the stone wall by the boat ramp will not be affected. The Commission Members agreed that this project should be conditioned under a notice of intent filing, with a plan showing the wetlands and marsh delineation. J. Hartley moved to close the hearing; W. Carreau seconded; voted unanimously. L. Dorman moved to issue a positive determination for boxes 1 and 3; J. Hartley seconded; voted unanimously.

7:10 PM **WILLIAM A. SAMPSON** - RFD (41D-1413) to raze the existing dwelling at 43 Dexter Road, Dexter Beach, and reclaim the yard by clearing brush up to 15' from the wetland line (continued from May 12, 2010). Mr. Sampson, by email, asked for another continuation because he has not yet had the wetland line reflagged. J. Hartley moved to continue the hearing, with the Applicant's consent, to 7:00 PM July 14, 2010; L. Dorman seconded; voted unanimously.

7:12 PM **JAMES E. COLAGEO**'s request for a certificate of compliance for constructing a dwelling, a deck, a garage, retaining walls and a septic system at 41 River Road was discussed (SE 041-872). Mr. Colageo had submitted a site plan showing the outbuildings. N. Hills moved to issue a full certificate of compliance; L. Dorman seconded; voted unanimously.

7:16 PM **TOWN OF MARION** - a memo will be sent to D.P.W. Superintendent Robert Zora asking him to meet with the Conservation Commission Members at the Sprague's Cove Storm Water Remediation Project (SE 041-556) at Silvershell Beach on Saturday, June 19, 2010, to discuss annual maintenance issues and vista pruning.

7:20 PM **CHRISTOPHER BRYANT** - NOI (SE 041-1138) to construct a one-half-acre aquaculture project in Job's Cove (continued from May 26, 2010). No one represented Mr. Bryant. The turtle study requested by the Natural Heritage and Endangered Species Program has not been received. N. Hills moved to continue the hearing to 7:10 PM July 14, 2010; J. Hartley seconded; voted unanimously.

Meeting adjourned at 7:30 PM.
